 Campbell, Caroline Purvis formerly Caroline Campbell, Alexander  
 Campbell, Harriet McKainie formerly Harriet Campbell  
 Daniel Campbell and Daniel McKainie husbands of the  
 said Harriet Campbell heirs at Law of the said Duncan  
 N. Campbell of the first part for and in consideration of  
 the sum of Three Hundred Dollars to us in hand paid  
 the receipt of which is hereby acknowledged have this day bargained  
 sold conveyed & delivered unto John M. Butte of the second  
 part all parties living & being in the County and State above written  
 The following described lot or parcel of Land being and lying  
 in the said County of Wiley & State above written lying in the  
 Land District Subject for sale at Cahawba a Town, The west half  
 of the south west quarter of Section Eleven in Township twelve  
 of Range Seven, containing twenty nine acres & eight three hundredths  
 of an acre also the north east quarter of the south west quarter  
 of Section Eleven in township twelve of Range Seven containing  
 thirty nine acres and ninety one and a half hundredths of  
 an acre Making in all one hundred & ninety two acres and  
 twenty four and a half hundredths of an acre more or less  
 to have and to hold the same to himself the said John M. Butte  
 his heirs Executors Administrators and assigns together with  
 all the improvements appertaining to the premises forever  
 And we do warrant and defend to him the said Butte  
 his heirs and assigns forever the title to the said Land herein  
 conveyed In testimony whereof we the parties of the first  
 part have signed with our own hands and seal this  
 the day and year before written
